Manufacturer's 3-Year Limited Warranty Agreement - 2009

The following warranty covers Vitrifrigo products, provided by Vitrifrigo America LLC, and is subject to the qualifications indicated herein. Vitrifrigo America warrants, for the periods set forth below, that products manufactured or supplied, will be free from defects in workmanship and material, provided such products are installed, operated and maintained in accordance with the written instructions provided by Vitrifrigo America.

New units are warranted for a period of two (2) years from the date of installation or sale, for all parts, except the compressor. The compressor, only, is warranted for a period of three (3) years from the date of installation or sale.

Labor will be paid, as outlined, in the Schedule of Limited Warranty Allowances for removal and reinstallation of components for a period of one (1) year from the date of installation. Warranty will be paid in accordance with the established schedule of allowances, herein. Compensation for warranty repairs is made only to Vitrifrigo America's authorized service organizations or upon prior written or verbal approval directly from an authorized representative from Vitrifrigo America.

Vitrifrigo America will repair or replace, at its option, components found to be defective due to faulty materials or workmanship when such components, examined by an authorized service dealer or factory service representative, are found to have a defect for which the company is responsible. Replacement components are warranted

for the duration of the remaining warranty period in effect on the original equipment.

All implied warranties, including merchantability and fitness for a particular purpose, are limited to the terms and periods set forth herein. To the extent permitted by law, any and all implied warranties are excluded.

The limited warranty is extended in lieu of all other warranties, agreements or obligations, expressed or implied, concerning Vitrifrigo America's components. This warranty is extended only to the original purchaser and is not transferable. This warranty shall be governed by the laws of the state of Florida and gives the original user definite legal rights.

This warranty does not cover damages that are incidental or consequential to the failure of Vitrifrigo America's equipment including but not limited to normal wear, accident, abuse, misuse, negligence or improper installation, lack of reasonable and necessary maintenance, alteration, civil disturbance or acts of God.

No person or dealer is authorized to extend any other warranties or to assume any other liabilities, on Vitrifrigo America's behalf, unless made, in writing, by an officer of Vitrifrigo America LLC.
