### **Appropriate engineering controls**

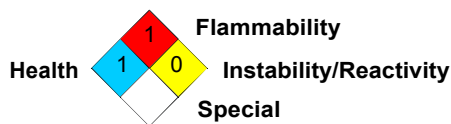
